TERMS & CONDITIONS - U.S.A.

Mar 1 to Apr 30, 2016 Consumers who buy four Dick Cepek DC Terrain, DC Matrix, DC Blackout, DC-2 Black, DC Gun Metal 7, or DC Torque wheels will receive a \$75 Prepaid Card by mail and consumers who buy four Dick Cepek Trail Country, Fun Country, Mud Country, Extreme Country, or Crusher tires will receive a \$100 Prepaid Card by mail. Here's how:

1. This offer is open to legal residents of the 50 United States, the District of Columbia, and Puerto Rico making purchases in participating retail stores in those locations. The mail-in offer is not transferable and is valid only for the individual who purchased four new qualifying Dick Cepek wheels in a single transaction for personal household use. Properly submitted and verified claims will be provided with the reward (as described below) in U.S. dollars in the form of a Dick Cepek Tires Visa® Prepaid Card, to be mailed to the address provided on this official mail-in form.
